### ***This plan is for you!***

1. Fill out the application form (you can find on line at [northwoodpool.com](http://northwoodpool.com) or at the pool office) and send it in, please follow the instructions that are listed on it. There is a \$25 application fee.
2. Once the application is approved by the Board, you will receive a letter welcoming you.
3. Next, please send in the annual dues and ½ the initiation fee, make note that you want to use the financing option for the remaining money owed (stock fee & 2<sup>nd</sup> half of initiation fee) by using the form titled, **FINANCE OPTION SIGNATURE FORM** that is listed below.
4. You will then be given a FO-number and will be allowed access to the pool for the 2009 season. This will be done by our membership committee.
5. By summers end or Mid September, you will receive a letter from the membership committee. This letter will remind you to start making pmts in September – April of the following year towards the stock fee and 2<sup>nd</sup> half of the initiation fee. Your payments will be \$101 per month due by the 20<sup>th</sup> of each month (you will have a 5 day grace period).

*If we do not receive any money from you, we will assume you are not joining the pool. All money paid to this point is non-refundable and was for the single season use. Please remember, this is a one time option per family. This is not intended for annual attendance without officially joining. Any considerations outside of this rule will have to have written board approval.*

6. When we receive your final payment in April, we will confirm your member number and send you the stock certificate that you just purchased in the club.
